RESOLUTION AUTHORIZING THE HON. MA. ESTER HAMOR, CITY MAYOR, SORSOGON CITY TO GRANT FINANCIAL ASSISTANCE TO TRICYCLE OPERATORS AND DRIVERS IN SORSOGON CITY.

**WHEREAS**, amid Global threat of COVID 19 Pandemic, national policies were initiated focused on curving the spread and incidence of COVID 19 cases in the country;

**WHEREAS,** Enhanced Community Quarantine was effected in entire Luzon commencing the mid part of the month of March 2020;

**WHEREAS,** following the aforementioned national directives, Social and Physical Distancing was also effected suspending tricycle operations while under the Enhanced Community Quarantine;

**WHEREAS**, sometime in the last week of April 2020, after assessment of the Inter Agency task Force (IATF), the Province of Sorsogon was downgraded to General

Community Quarantine (GCQ) effective May 01, 2020, wherein among others, tricycle transport operations are allowed to operate at minimal number and with one passenger per trip;

**WHEREAS,** in cognizance of the plight of the tricycle transport sector in these trying times, and in recognition of the necessity to provide public conveyance to local constituents even in a minimal number, thus, this resolution;

**WHEREAS**, for purposes of resolution, the financial aid to be extended as herein provided shall be in the amount of Five Hundred (P 500.00) Pesos per franchise holder and driver;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to grant financial assistance to tricycle operators and drivers in Sorsogon City;

**NOW THEREFORE**, on motion of **CITY COUNCILOR NESTOR J. BALDON** duly seconded by City Councilor **ERWIN J. DUANA**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to grant financial aid to tricycle operators and drivers in Sorsogon City;
