RESOLUTION MOST RESPECTFULLY REQUESTING SORSOGON II ELECTRIC COOPERATIVE (SORECO II) MANAGEMENT TO EXPLAIN AND JUSTIFY THE SUDDEN INCREASE IN THE CHARGES OF ELECTRIC BILLS TO THE MEMBER-CONSUMERS IN SORSOGON CITY.

WHEREAS, Republic Acts 11469 and 11332 complemented by pronouncements by the National Government and duly adopted by both the Provincial and City Governments which were all intended to protect the health and safety of the constituents;

WHEREAS, these preventive and remedial measures against the menace of COVID-19 resulted to economic dislocation among the citizenry;

WHEREAS, among the most and hardly affected is the underprivileged and the marginalized sector;

WHEREAS, during the past months **SORECO** Management faithfully complied with the restrictions imposed by the National dispensation with the corresponding support by the Local Government Units;

WHEREAS, **SORECO II** Management adopted measures in order to ensure continuity of service which the member-consumer believed to have caused the sudden increase in their electric bills;

NOW THEREFORE, on motion of **CITY COUNCILOR FERNANDO DAVID H. DURAN, III** duly seconded by **CITY COUNCILOR ERWIN J. DUANA**, resolve as it is hereby resolved to most respectfully request Sorsogon II Electric Cooperative (**SORECO II**) Management to explain and justify the sudden increase in the charges of electric bills to the member-consumers in Sorsogon City.
