RESOLUTION AUTHORIZING THE HON. MA. ESTER HAMOR, CITY MAYOR, SORSOGON CITY TO GRANT FINANCIAL ASSISTANCE TO JEEPNEY OPERATORS AND DRIVERS IN SORSOGON CITY.

WHEREAS, amid Global threat of COVID 19 Pandemic, national policies were initiated focused on curving the spread and incidence of COVID 19 cases in the country;

WHEREAS, Enhanced Community Quarantine was effected in entire Luzon commencing the mid part of the month of March 2020;

WHEREAS, following the aforementioned national directives, Social and Physical Distancing was also effected suspending jeepney operations while under the Enhanced Community Quarantine;

WHEREAS, sometime in the last week of April 2020, after assessment of the Inter Agency task Force (IATF), the Province of Sorsogon was downgraded to General

Community Quarantine (GCQ) effective May 01, 2020, wherein among others, jeepney transport operations are allowed to operate at minimal number and with 50% of the sitting passenger capacity per trip;

WHEREAS, in cognizance of the plight of the jeepney operators and drivers in these trying times, and in recognition of the necessity to provide public conveyance to local constituents even in a minimal number, thus, this resolution;

WHEREAS, for purposes of this resolution, the financial aid to be extended as herein provided shall be in the amount of Five Hundred (P 500.00) Pesos and additional Two Hundred (P 200.00) Pesos in the form of gasoline;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to grant financial assistance to jeepney operators and drivers in Sorsogon City;

NOW THEREFORE, on motion of **CITY COUNCILOR FRANCO ERIC O. RAVANILLA** duly seconded by **CITY COUNCILOR NESTOR J. BALDON**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to grant financial aid to jeepney operators and drivers in Sorsogon City;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.


