RESOLUTION ENACTING ORDINANCE RECLASSIFYING FROM AGRICULTURAL TO COMMERCIAL USE THE PARCEL OF LAND UNDER TCT NO. T-37534 AND ARP NO. 2011-03-0010-01473, CONTAINING AN AREA OF 4,000 SQUARE METERS SITUATED AT BARANGAY GUINLAJON, WEST DISTRICT, SORSOGON CITY

WHEREAS, the application for the herein reclassification measure was calendared during the August 27, 2019, Regular Session of the 7th City Council and was subsequently referred to the Committee on Land Use, Urban Planning and Housing;

WHEREAS, in compliance with the provisions under RA 7160, otherwise known as the Local Government Code of 1991, on September 6, 2019, the Committee on Land Use, Urban Planning and Housing conducted its public hearing for the purpose and recommended that an ordinance to that effect be passed for the reclassification of the said lot;

WHEREAS, reclassification as herein approved implies amendments to the Sorsogon City Zoning Ordinance and its corresponding Comprehensive Land Use Plan;

WHEREAS, the herein reclassification should be understood as a prerequisite for the land conversion application before the Department of Agrarian Reform (DAR);

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to enact an ordinance reclassifying from agricultural to commercial use the parcel of land under TCT No. T-37534 and ARP No. 2011-03-0010-01473, containing an area of 4,000 square meters situated at Barangay Guinlajon, West District, Sorsogon City.

City Ordinance No. 012, Series of 2019

AN ORDINANCE RECLASSIFYING FROM AGRICULTURAL TO COMMERCIAL USE THE PARCEL OF LAND UNDER TCT NO. T-37534 AND ARP NO. 2011-03-0010-01473, CONTAINING AN AREA OF 4,000 SQUARE METERS SITUATED AT BARANGAY GUINLAJON, WEST DISTRICT, SORSOGON CITY

Be it ordained by the Sangguniang Panlungsod in session that:

SECTION 1 SCOPE/COVERAGE

This ordinance shall cover and limited to the reclassification from agricultural to commercial use the parcel of land under TCT No. T-37534 and ARP No. 2011-03-0010-01473, containing an area of 4,000 square meters situated at Barangay Guinlajon, West District, Sorsogon City.

Further, such classification shall be used solely for the purpose as applied/intended for.

SECTION 2 RECLASSIFICATION CLAUSE

It is hereby reclassified from agricultural to commercial use the parcel of land under TCT No. T-37534 and ARP No. 2011-03-0010-01473, containing an area of 4,000 square meters situated at Barangay Guinlajon, West District, Sorsogon City.

SECTION 3 AMENDATORY CLAUSE

Provisions of the City Ordinance No. 005, Series of 2008 otherwise known as the City Zoning Ordinance and part of the Official General Land Use Map/Comprehensive Land Use Plan (CLUP) of the City Government of Sorsogon covering the herein mentioned reclassification are hereby deemed amended for the purpose.

SECTION 4 REPEALING CLAUSE

All ordinances, resolutions and regulations, or any part(s) thereof which are inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 5 SEPARABILITY CLAUSE

If for any reason or reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6 EFFECTIVITY

This ordinance shall take effect immediately upon its approval by the Sangguniang Panlungsod and after compliance with the law on public dissemination and of publication.
