RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF THE DEPUTY EXECUTIVE SECRETARY FOR FINANCE AND ADMINISTRATION RELATIVE TO THE GRANT OF FINANCIAL ASSISTANCE TO THE CITY GOVERNMENT OF SORSOGON.

WHEREAS, on May 18, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Members of the 7th City Council through Mr. Dan G. Alcala, Acting Secretary to the Sangguniang Panlungsod respectfully requesting among others the passage of a resolution authorizing the local chief executive to enter into a Memorandum of Agreement (MOA) with the Office of the Deputy Executive Secretary for Finance and Administration relative to the grant of financial assistance to the City Government of Sorsogon;
