RESOLUTION ADOPTING A TEMPORARY SCHEDULING SYSTEM UTILIZING THE COLOR CODING SCHEME FOR TRICYCLE FOR HIRE OPERATING IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON IN CONSONANCE WITH THE EXECUTIVE ORDER ISSUED BY HON. FRANCIS JOSEPH ESCUDERO, PROVINCIAL GOVERNOR, PROVINCE OF SORSOGON AND THE RELEVANT PROVISIONS OF THE INTER AGENCY TASK FORCE –EMERGING INFECTIOUS DISEASES (AITF-EID).

WHEREAS, while the Province of Sorsogon was placed under the Enhanced Community Quarantine, all public conveyances transport operations to include Tricycle For Hire were halted in consonance with the guidelines issued by the Inter Agency task Force-Emerging Infectious Diseases (AITF-EID);

WHEREAS, the intent and purpose of the preceding statement is strictly implement Social and Physical Distancing as part of the measures in order to combat the spread of COVID 19 Pandemic;

WHEREAS, effective May 01, 2020, the Province of Sorsogon was downgraded to General Community Quarantine and immediately thereof, the 7th City Council authorized the minimal presence of Tricycle For Hire in the Territorial Jurisdiction of the City allowing 20% percent operation of the total tricycle for hire in the City of Sorsogon, thus by simple computation, tricycle franchise holders are allowed to operate once on weekdays;

WHEREAS, in consonance with existing declarations of relevant authorities and in consideration of the plight of tricycle transport sector in this trying times, hereunder are the TEMPORARY SCHEDULING SYSTEM UTILIZING THE COLOR CODING SCHEME FOR TRICYCLE FOR HIRE OPERATING IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON:
