RESOLUTION ENDORSING THE REQUEST OF THE SORSOGON CITY FIRE STATION (SCFS) FOR THE PROVISION OF AN ADDITIONAL FIRE TRUCK TO THE BUREAU OF FIRE PROTECTION (BFP) AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG)

WHEREAS, among the items deliberated during the September 10, 2019 Regular Session of the 7th City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP dated September 5, 2019 requesting for the passage of a resolution endorsing the request for the provision of an additional fire truck for the Sorsogon City Fire Station (SCFS) to the Bureau of Fire Protection and the Department of the Interior and Local Government;

WHEREAS, the Sorsogon City Fire Station (SCFS) is one of the closest partners of the City Government in providing the people with the safety and security that they need in their everyday lives;

WHEREAS, in a letter dated August 29, 2019, the SCFS presented their current situation regarding the number of operational fire trucks wherein they are lacking of service vehicles in order to allow them to efficiently respond to any situation that may arise in the City of Sorsogon;

WHEREAS, the request for an acquisition of additional service vehicle intended to be stationed at Bacon District, Sorsogon City in which the city government cannot grant due to insufficiency of funds for their operational expenses;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution endorsing the request of the Sorsogon City Fire Station (SCFS) for the provision of an additional fire truck to the Bureau of Fire Protection (BFP) and the Department of the Interior and Local Government (DILG);

NOW THEREFORE, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolve as it is hereby resolved to endorse the request of the Sorsogon City Fire Station (SCFS) for the provision of an additional fire truck to the Bureau of Fire Protection (BFP) and the Department of the Interior and Local Government (DILG);
