RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO EXTEND FINANCIAL ASSISTANCE TO ALL BARANGAY KAGAWAD IN THE CITY OF SORSOGON IN RECOGNITION OF THEIR HARD WORK DURING THE ENHANCED COMMUNITY QUARANTINE AMID COVID 19

WHEREAS, on March 17, 2020, a memorandum order from the Office of the President placed the whole island of Luzon under Enhance Community Quarantine (ECQ) and subsequently the Province of Sorsogon had been placed to General Community Quarantine (GCQ);

WHEREAS, during the period of ECQ, lockdown and stoppage or suspension of work in the public and private establishments and employment were enforced;

WHEREAS, in compliance with the guidelines imposed by the IATF for COVID 19, barangay officials conducted an intensified monitoring, enforced curfew hours and all other security and medical protocols for the purpose;

WHEREAS, the City Government extended an assistance in the amount of Thirteen Thousand Two Hundred (P13, 200.00) Pesos only (P300 x 22 (days) x 2 (mos.)) for each Barangay Secretary and Barangay Treasurer which were already downloaded to the barangays for their disposal;

WHEREAS, it is therefore the humble request of the Liga ng mga Barangay to also extend the same financial aid to all Barangay Kagawad in the City of Sorsogon in recognition also for their hard work during the Enhanced Community Quarantine amid Covid 19, to which they are also exposed to risk and hazard by the said pandemic;

NOW THEREFORE, on motion of Hon. Ma. Teresa D. Perdigon, duly seconded by Hon. Joven G. Laura, resolve as it is hereby resolved to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to extend financial assistance to all Barangay Kagawad in the City of Sorsogon in recognition of their hard work during the Enhanced Community Quarantine amid Covid 19;
