RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO DEED OF CONDITIONAL DONATION WITH THE CIVIL SERVICE COMMISSION (CSC) REPRESENTED BY ITS CHAIRPERSON, ALICIA DELA ROSA-BALA RELATIVE TO A PARCEL OF LAND (LOT 8 OF THE SUBDIVISION SURVEY PSD-05-045231, BEING PORTION OF LOT 4, PCS-05-002072) LOCATED AT THE CITY HALL COMPOUND, BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the September 10, 2019 Regular Session of the 7th City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP dated September 9, 2019 requesting for the passage of a resolution authorizing the donation of a parcel of land (Lot 8 of the subdivision survey psd-05-045231, being a portion of lot 4, pcs-05-002072) to Civil service Commission (CSC) and authorizing the chief executive in her capacity as City Mayor of Sorsogon to enter into and sign the conditional Deed of Donation in favor of the CSC;

WHEREAS, on August 20, 2019 the Civil Service Commission wrote a letter to the chief executive requesting the city government of Sorsogon to donate a parcel of land within the perimeter of the Sorsogon City Compound wherein a new CSC Field Office is to be constructed;

WHEREAS, at present the CSC field office was temporary housed at PCL Building, Capitol Compound, Sorsogon City after their office has been demolished due to the ongoing rehabilitation of the Provincial Capitol Compound;

WHEREAS, attached to the letter request is a draft copy of the Deed of Conditional Donation for further perusal of the 7th City Council;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into Deed of Conditional Donation with the Civil Service Commission (CSC) represented by its chairperson, Alicia Dela Rosa-Bala relative to a parcel of land (Lot 8 of the subdivision survey psd-05-045231, being a portion of lot 4, pcs-05-002072) located at the City Hall Compound, Barangay Cabid-An, East District, Sorsogon City;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E.
