RESOLUTION ENJOINING MR. GERALD MALIGASO, CITY GENERAL SERVICES OFFICER TO RECALL ALL GOVERNMENT VEHICLES AND OFFICE EQUIPMENTS ISSUED TO CITY EMPLOYEES OF THE LEGISLATIVE DEPARTMENT FOR PURPOSES OF PHYSICAL INVENTORY AND TO MAXIMIZE ITS USAGE.

WHEREAS, for purposes of delivery of legislative services as mandated under Republic Act 7160 otherwise known as the Local Government Code of 1991, government vehicles and office equipments were procured;

WHEREAS, records from the City General Services Office (CGSO) reflect several government vehicles and office equipments issued to legislative employees;

WHEREAS, for purposes of effective and efficient delivery of legislative services, there is a need to conduct an immediate physical inventory of government vehicles and office equipments under the legislative department in order to streamline its usage according to legislative functions;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution enjoining Mr. Gerald Maligaso, City General Services Officer to recall all government vehicles and office equipments issued to City Employees of the Legislative Department for purposes of Physical Inventory and to Maximize its Usage.
