**RESOLUTION ENDORSING THE SITE LOCATED AT BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY, WITH TEN THOUSAND SIX HUNDRED SEVENTY THREE (10,673) SQUARE METERS, COVERED BY TCT NO. 12, LOT NO. 4095 BE DECLARED AS THE RESETTLEMENT SITE VIS-À-VIS SP RESOLUTION NO. 026, SERIES OF 2019**

**WHEREAS**, among the items deliberated during the September 10, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP dated September 9, 2019 requesting for the passage of a resolution endorsing the site located at Barangay Cabid-An, East District, Sorsogon City, with Ten Thousand Six Hundred Seventy Three (10,673) Square Meters, covered by TCT No. 12, Lot No. 4095 which shall generate One Hundred Sixty Four (164) lots be declared as the resettlement site vis-à-vis SP Resolution No. 026, Series of 2019;

**WHEREAS**, the City Government of Sorsogon is in need of a resettlement project to accommodate families affected by the road widening infrastructure projects of the National Government and those underprivileged families who are ejected from their dwellings by virtue of court order as well as those families who are living in vulnerable areas;

**WHEREAS**, the proposed project as Resettlement Site has an area of Ten Thousand Six Hundred Seventy Three (10,673) Square Meters, located at Barangay Cabid-An, East District, Sorsogon City registered in the name of the Republic of the Philippines covered by TCT No. 12, Lot No. 4095 that will generate One Hundred Sixty Four (164) lots in favor of Informal Settler Families (ISF) Beneficiaries;

**WHEREAS**, attached thereto is the request for endorsement of the National Housing Authority thru Sangguniang Panlungsod Resolution for further perusal of the 7<sup>th</sup> City Council;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution endorsing the site located at Barangay Cabid-An, East District, Sorsogon City, with Ten Thousand Six Hundred Seventy Three (10,673) Square Meters, covered by TCT No. 12, Lot No. 4095 be declared as the Resettlement Site vis-à-vis SP Resolution No. 026, series of 2019;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to endorse the site located at Barangay Cabid-An, East District, Sorsogon City, with Ten Thousand Six Hundred Seventy Three (10,673) Square Meters, covered by TCT No. 12, Lot No. 4095 be declared as the Resettlement Site vis-à-vis SP Resolution No. 026, series of 2019;
