WHEREAS, following technological advancement at present, cellular phones play a vital role in business sectors operations and communicating with friends and relatives;

WHEREAS, at this point, telecommunication companies intend to install cellular sites in strategic locations in the locality for purposes of efficient and effective delivery of services to their millions of clients;

WHEREAS, in view thereof, hereunder are the requirements in relation to the aforementioned to wit;
