RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE NO. 5 RELATIVE TO THE TULONG PANGHANAPBUHAY SA ATING DISPLACED/ DISADVANTAGED (TUPAD) WORKERS PROGRAM AS A POST-COVID INTERVENTION.

WHEREAS, on June 01, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to Hon. Mark Eric C.
