RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT OFFICE (DSWD) REGIONAL OFFICE NO. 5 REPRESENTED BY ITS REGIONAL DIRECTOR RELATIVE TO THE SUPPLEMENTARY FEEDING PROGRAM (SFP)

WHEREAS, on May 26, 2020, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Members of the 7th City Council through Mr. Dan G. Alcala, Acting Secretary to the Sangguniang Panlungsod respectfully requesting among others the passage of a resolution authorizing the local chief executive to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD)

represented by its Regional Director relative to the Supplementary Feeding Program (SFP);

WHEREAS, Supplementary Feeding Program (SFP) is part of the government response to the localized community quarantine in different parts of the country brought about by corona virus disease (COVID-19) pandemic;

WHEREAS, this program is one of the safety nets as conceptualized to curtail the impact of health and economic emergencies to all vulnerable sectors which include children of formative years as directed in RA 11469 otherwise known as the “Bayanihan To Heal As One Act”;

WHEREAS, attached to the aforementioned letter duly certified as urgent by the local chief is the Draft Memorandum of Agreement (MOA) by and between the City Mayor and the Department of Social Welfare and Development (DSWD), Regional Office V represented by its Regional Director relative to the Supplementary Feeding Program (SFP) for perusal of the august body;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare And Development (DSWD) Regional Office No. V represented by its Regional Director relative to the Supplementary Feeding Program (SFP);


NOW THEREFORE, on motion of **City Councilor Mary Ellen D. Jamisola** duly seconded by **City Councilor Jo Abegail C. Dioneda**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Regional Office No. V represented by its Regional Director relative to the Social Amelioration Program.
