RESOLUTION APPROVING THE HEREUNDER APPLICATIONS FOR TRANSFER OF FRANCHISE HOLDER TO A QUALIFIED FRANCHISE APPLICANT

WHEREAS, in compliance with the resolution unanimously approved by the 3rd City Council requiring tricycle operators to secure a Sangguniang Panlungsod Resolution of their tricycle franchise, an information and dissemination campaign through interviews in radio stations, distribution of leaflets and flyers was initiated by the Office of the Secretary to the Sangguniang Panlungsod;
