RESOLUTION URGING THE SK3 TO STRICTLY IMPLEMENT CITY ORDINANCE NO. 010, SERIES OF 2007 OTHERWISE KNOWN AS THE SORSOGON CITY RUSH HOUR TRAFFIC MANAGEMENT ORDINANCE OF 2007.

WHEREAS, on November 20, 2007, the City Council passed and approved City Ordinance No. 010, series of 2007 otherwise known as the Sorsogon City Rush Hour Traffic Management Ordinance of 2007;

WHEREAS, the intent and purpose of the passage of the aforementioned city ordinance is to regulate the use of main thoroughfares during rush hours thereby decongesting traffic;

WHEREAS, for purposes of resolution, SK 3 through the representation Mr. Arnel H. Anchinges is hereby advise to strictly implement the herein mentioned city ordinance while in the course of slowly allowing tricycles for hire and other Public Utility Vehicles to operate in the locality;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution urging the SK3 to strictly implement City Ordinance No. 010, series of 2007 otherwise known as the Sorsogon City Rush Hour Traffic Management Ordinance of 2007;

NOW THEREFORE, on motion of **City Councilor Nestor J. Baldon** duly seconded by **City Councilor Franco Eric O.
