RESOLUTION ADOPTING EXECUTIVE ORDER NO. 44, SERIES OF 2020 ISSUED BY HON. FRANCIS JOSEPH G. ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON PROVIDING FOR GUIDELINES IN THE IMPLEMENTATION OF MODIFIED GENERAL COMMUNITY QUARANTINE IN THE PROVINCE OF SORSOGON AND FOR OTHER PURPOSES.

WHEREAS, following protocol procedures imposed by Inter Agency Task Force (IATF) amid COVID 19, the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon issued several Executive Orders with the main goal of protecting the interest of those within the territorial jurisdiction of the Province of Sorsogon;

WHEREAS, upon classification of the Province of Sorsogon under Modified General Community Quarantine by the Inter Agency Task Force, the Governor immediately issued Executive Order No. 44, series of 2020 taking into consideration the

affected business environment and other sectors while bearing in mind to strictly implement minimum health protocols imposed upon by appropriate agencies in order to combat the spread of COVID 19 in our locality;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution adopting Executive Order No. 44, series of 2020 issued by Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon providing for Guidelines in the Implementation of Modified General Community Quarantine in the Province of Sorsogon and for other purposes;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Danilo A. Deladia**, resolve as it is hereby resolved to adopt Executive Order No. 44, series of 2020 issued by Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon providing for Guidelines in the Implementation of Modified General Community Quarantine in the Province of Sorsogon and for other purposes;
