RESOLUTION INTERPOSING NO OBJECTION TO THE OPERATION OF THREE JM WATER TREATMENT FACILITY AT BRGY. SUGOD, BACON DISTRICT, SORSOGON CITY.

WHEREAS, on October 11, 2019, Ms. Marilyn C. Dolot, owner of Three JM Water Supply Services, Brgy. Sugod, Bacon District, Sorsogon City wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Members of the 7th City Council respectfully requesting for an issuance of permit to operate of the water treatment facility which was reflected in the agenda during the Regular Session on October 22, 2020 and thereafter referred to the Committee on Public Utilities;

WHEREAS, on November 13, 2020, a committee hearing therefor was conducted for the purpose with a recommendation for the City Health Office and City Engineering Office to conduct joint ocular site inspection and require the applicant to submit before the committee the site inspection report;

WHEREAS, for purposes of compliance to the recommendation under Committee Report No. 106, Series of 2020 of the Committee on Public Utilities, an ocular inspection report was submitted by Engr. Joelan D. Aguirre of the City Engineering Office relative to the application of Three JM Water Supply at Brgy. Sugod, Bacon District, Sorsogon City;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th city council deemed it necessary to pass a resolution interposing no objection to the operation of Three JM Water Treatment Facility at Brgy. Sugod, Bacon District, Sorsogon City;

NOW THEREFORE, on motion of City Councilor **Franco Eric O. Ravanilla**, duly seconded by City Councilor Rebecca D.
