**RESOLUTION MOST RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO INSTALL MARKERS AT SORSOGON BAY IN ORDER TO DELINEATE THE SORSOGON CITY TERRITORIAL WATER JURISDICTION THEREOF**

**WHEREAS**, it is the mandate for the local government unit to exercise the powers expressly granted, those necessarily implied therefrom, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, the National Mapping and Resources Information Agency (NAMRIA) in the past has already technically described the territorial waters of Sorsogon City bounded by its general coastline and its coordinates;

**WHEREAS**, in the territorial waters of Sorsogon City in Sorsogon Bay, it shall be confined within the land from and between the political boundary of Barangay Abuyog, Sorsogon City and Barangay Boton, Casiguran;

**WHEREAS**, extending westward up to the point of vertical line from the political boundary of Barangay Panlayaan, Sorsogon City and Dancalan of the Municipality of Castilla and in South of it is bounded by the municipal waters of Casiguran and Juban and in the West by the Municipal Waters of Castilla;

**WHEREAS**, recently there were alleged reports of Sorsogon City Fisher Folks being apprehended by fishery enforcers from the Municipality of Juban and Casiguran being that they are engaged in fishing within the territorial waters thereof;

**NOW THEREFORE**, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolve as it is hereby resolved to most respectfully request the **Hon. Ma. Ester E. Hamor**, City Mayor, Sorsogon City to install markers at Sorsogon Bay in order to delineate the Sorsogon City Territorial Water Jurisdiction thereof;
