RESOLUTION URGING THE END USERS OF MOTOR VEHICLES AND OFFICE EQUIPMENT IN CLOSE COORDINATION WITH THE PERSON/ EMPLOYEE WITH MEMORANDUM RECEIPTS THEREFOR UNDER THE LEGISLATIVE DEPARTMENT TO UNCONDITIONALLY SURRENDER THESE CHATTELS TO THE CITY GENERAL SERVICES OFFICE (CGSO) WITH DISPATCH FOR PURPOSES OF RE-ISSUANCE.

WHEREAS, time and again, the fundamental law has been explicit on its provisions advocating honesty, dignity, efficiency and accountability of employees and public officials employed in government agencies including quasi-government institutions complemented by various laws, rules and regulations for the strict adherence therefor lest suffer the penalties corresponding to the offense committed;

WHEREAS, it is of common knowledge, these rules, policies and regulations have been abused and transgressed by unscrupulous and incorrigible employees and officials in collusion with private individuals only to pursue, promote and protect their vested interest to the great disadvantage and wastage of public money and taxes levied to the taxpayers;

WHEREAS, there are local government units whose employees and government officials have been religious, faithful and compliant with thrusts of their local governments to ensure good, honest and transparent governance. This on the other hand is tainted and marred by few unscrupulous employees and officials;

NOW THEREFORE, on motion of **City Councilor Joven G. Laura**, duly seconded by City Councilor **Hon. Franco Eric O. Ravanilla** resolve as it is hereby resolved to urge the end users of motor vehicles and office Equipment in close coordination with the person/employee with memorandum receipts therefor under the Legislative Department to unconditionally surrender these chattels to the City General Services Office (CGSO) with dispatch for purposes of re-issuance.
