WHEREAS, among the items deliberated during the September 17, 2019 Regular Session of the 7<sup>th</sup> City Council is the approved Barangay Resolution No. 39, Series of 2019 of the Barangay Council Of Burabod, East District, Sorsogon City entitled: Resolution respectfully requesting the Hon.
