WHEREAS, among the items deliberated during the September 17, 2019 Regular Session of the 7th City Council is the approved Barangay Resolution No. 39, Series of 2019 of the Barangay Council Of Burabod, East District, Sorsogon City entitled: Resolution respectfully requesting the Hon. Ma. Ester E.
