**RESOLUTION MOST RESPECTFULLY REQUESTING THE LOCAL WATER UTILITIES ADMINISTRATION TO CONSIDER WITH FINALITY THE RESIGNATION OF BOARD OF DIRECTORS AND OFFICERS OF THE SORSOGON CITY WATER DISTRICT AND PRIME WATERS, SORSOGON CITY**

**WHEREAS**, Atty. Roberto T. Labitag, City Legal Officer, Sorsogon City thru a letter dated August 29, 2019 endorsed to the Chief Executive a measure for the declaration of vacancy of the positions of the Officers and Board of Directors of Sorsogon City Water District/Prime Water, Incorporated;

**WHEREAS**, the aforesaid letter-request was predicated on the prerogative of the chief executive to appoint new sets of officers and Board of Directors;

**WHEREAS**, as a consequence thereof, Officers and Board of Directors of Sorsogon City Water District/Prime Water tendered their respective resignations subject to a condition that the Local Water Utilities Administration should accept and approve the same;

**WHEREAS**, prior to the joint venture agreement of Sorsogon City Water District/ Prime Water, Incorporated there were adjustments and changes in the management thereof particularly its Board of Directors and Officers aimed at improving its services to the constituents and likewise introducing new projects for similar purpose;

**WHEREAS**, despite some drastic changes in the management thereof, the consumers are dissatisfied with the retrogressive services of the joint venture agreement which adversely affected the welfare of the constituents;


**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution most respectfully requesting Local Water Utilities Administration to consider with finality the resignation of Board of Directors and Officers of the Sorsogon City Water District/Prime Waters, Sorsogon City;

Laura**, resolve as it is hereby resolved to most respectfully request the Local Water Utilities Administration to consider with finality the resignation of Board of Directors and Officers of the Sorsogon City Water District/Prime Waters, Sorsogon City;
