RESOLUTION MOST RESPECTFULLY REQUESTING THE NATIONAL INTER-AGENCY TASK FORCE (IATF) FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES TO ALLOW BACKRIDE IN MOTORCYCLE IN THE CITY OF SORSOGON WITH THE GOVERNING GUIDELINES AND POLICIES AS HEREIN DRAFTED FOR THE APPROVAL OR AUTHORIZATION OF THE IATF

WHEREAS, on March 17, 2020, a memorandum order from the Office of the President placed the whole island of Luzon under Enhance Community Quarantine (ECQ) and subsequently the Province of Sorsogon had been placed to General Community Quarantine (GCQ) and at present under the Modified General Community Quarantine (MGCQ);

WHEREAS, during the period of ECQ, lockdown and stoppage or suspension of work in the public and private employment were enforced including transport operation of all kind;

WHEREAS, under the MGCQ, essential and some establishments are allowed to resume their operation provided that the minimum requirements and health protocols shall be observed, however, laborers and workers found it difficult in going to and from their respective workplaces due to limited transportation access, brought about by similar requirements and protocols;

WHEREAS, for humanitarian reason and to start flourishing the local economy, laborers and workers in the City of Sorsogon which are now allowed to work subject to strict compliance of the aforesaid requirements and protocols, they should be provided with at least nominal if not an adequate modes of transportation service in the city;

WHEREAS, because of the one (1) passenger capacity/policy for tricycles-for-hire, and due to deficiency of accessible transportation, the city government intends to allow back-ride in motorcycles within the City of Sorsogon, with the following governing guidelines and policies as herein drafted for the approval or authorization of the IATF:

1. One (1) back-ride in motorcycle shall be allowed only for the residents of Sorsogon City from 6:00-9:00am, 12:00nn-2:00pm and 5:00-7:00pm.
2. Driver and back-ride shall wear their helmet from point to point. (From their house to their destination).
3. Back-ride shall be limited to driver's spouse, child and sibling (brother/sister).
4. Driver shall always bring his/her Driver's License and birth certificate and back-ride shall always bring their marriage contract or birth certificate as the case maybe.
5. 1,000 pairs of "Angkas Permit ID" shall be issued by the city government and shall be proportionately distributed to the 64 barangays.
6. The respective barangays shall issue the "Angkas Permit ID" to every household with a family member who is working outside the barangay.
7. The barangay shall maintain a copy of the names of the drivers and the list of beneficiaries with their respective serial number.
8. Such list and records shall be furnished to Traffic Management and Civil Security (TMECS) and to the City PNP.
9. TMECS and the City PNP shall maintain information desks and control points in all strategic areas in the city proper to monitor and apprehend violations hereof.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, **promote health and safety**, improve public morals, **enhance economic prosperity and social justice**, maintain peace and order and **preserve the comfort and convenience of their inhabitant**;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to pass a resolution most respectfully requesting the national Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases to allow back-ride in motorcycle in the city of Sorsogon with the governing guidelines and policies as herein drafted for the approval or authorization of the IATF.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
