RESOLUTION AUTHORIZING THE GRANT AND RELEASE OF FINANCIA' ASSISTANCE TO DRIVERS OF PUBLIC UTILITY JEEPNEYS (PUJs) IN TICITY OF SORSOGON

WHEREAS, on March 17, 2020, a memorandum order from the Office President placed the whole island of Luzon under Enhance Community Quarantir and subsequently the Province of Sorsogon had been placed to General Co-Quarantine (GCQ) and at present under the Modified General Community C (MGCQ);

WHEREAS, during the period of ECQ, lockdown and stoppage or work in the public and private employment were enforced including trans of all kinds;

WHEREAS, due to such predicament, the city government intends to grant and issue a financial assistance amid COVID 19 to all qualified drivers of the Public Utility Jeepneys (PUJs) in the city of Sorsogon;

WHEREAS, this measure further authorizes the immediate family members to receive the financial assistance as herein described for and in behalf of the qualified drivers of the PUJs who are already dead during the quarantine, Locally Stranded Individuals (LSIs), or with health problems, with the following additional documentary requirements, attached to Certificate of Franchise or Certificate Public Conveyance. Driver's License, to wit:

A. BENEFICIARIES OF DECEASED DRIVERS

- Death Certificate of the franchise holder
- Marriage Contract in case the surviving spouse is the claimant
- Birth Certificate in case the child is the claimant preferably of legal age and a written authorization to receive issued by the Mother, if still alive.

B. LOCALLY STRANDED INDIVIDUALS (LSIs)

- Certification from the barangay that the beneficiary was stranded or locked down in any part of the Philippines.
- Preferably, the claimant should be the spouse, if still alive. In such case, a Marriage Contract should be submitted.
- In the absence of the spouse, anyone of their children could substitute preferably of legal age. In such case, a Birth Certificate should be submitted with the written authorization of his/her father/mother left in the barangay, as the case maybe and if applicable.

C. WITH HEALTH PROBLEMS

- Medical Certificate of the beneficiary
 - -Preferably, the claimant should be the spouse, if still alive. In such case, a Marriage Contract should be submitted.
 - In the absence of the spouse, anyone of their children could substitute. In such case, a Birth Certificate should be submitted with the written authorization of the beneficiary.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to pass a resolution authorizing the grant and release of financial assistance to drivers of Public Utility Jeepneys (PUJs) in the City of Sorsogon.
