RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ALLOCATE FUND FOR THE REHABILITATION OF BARANGAY WATER SYSTEM FROM BARANGAY SAN JUAN TO BARANGAY POBLACION, LOCATED AT BACON DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the September 24, 2019 Regular Session of the 7th City Council is the issue raised by Hon. Hilario Dioneda regarding the concerns of most residents in Poblacion, Bacon District due to scarcity of water supply of the barangay water system in barangay San Juan to barangay Poblacion;

WHEREAS, the residents attributed the insufficiency or shortage to antiquated leaking and dilapidated pipe lines;

WHEREAS, it is of urgent necessity and to the best interest of the constituents to request the chief executive to allocate funds for the rehabilitation thereof;


WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution respectfully requesting the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to allocate funds for the rehabilitation of barangay water system from Barangay San Juan to Barangay Poblacion, located at Bacon District, Sorsogon City;

NOW THEREFORE, on motion of **Hon. Hilario D. Dioneda**, duly seconded by **Hon. Melchor P. Atutubo**, resolve as it is hereby resolved to respectfully request the Hon. Ma. Ester E.
