RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ALLOCATE FUND FOR THE REHABILITATION OF BARANGAY WATER SYSTEM FROM BARANGAY SAN JUAN TO BARANGAY POBLACION, LOCATED AT BACON DISTRICT, **SORSOGON CITY** 

WHEREAS, among the items deliberated during the September 24, 2019 Regular Session of the 7<sup>th</sup> City Council is the issue raised by Hon. Hilario Dioneda regarding the concerns of most residents in Poblacion, Bacon District due to scarcity of water supply of the barangay water system in barangay San Juan to barangay Poblacion;

WHEREAS, the residents attributed the insufficiency or shortage to antiquated leaking and dilapidated pipe lines;

WHEREAS, it is of urgent necessity and to the best interest of the constituents to request the chief executive to allocate funds for the rehabilitation thereof;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution respectfully requesting the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to allocate funds for the rehabilitation of barangay water system from Barangay San Juan to Barangay Poblacion, located at Bacon District, Sorsogon City;
