RESOLUTION AUTHORIZING THE IMMEDIATE FAMILY MEMBERS AS HEREIN IDENTIFIED TO RECEIVE THE FINANCIAL ASSISTANCE ISSUED BY THE CITY GOVERNMENT AMID COVID 19 FOR AND IN BEHALF OF THE QUALIFIED DRIVERS AND OPERATORS OR FRANCHISE HOLDERS OF TRICYCLE-FOR-HIRE WHO ARE ALREADY DEAD, OVERSEAS FILIPINO WORKERS (OFWs), LOCALLY STRANDED INDIVIDUALS (LSIs), WITH HEALTH PROBLEMS AND OLD AGED

WHEREAS, on March 17, 2020, a memorandum order from the Office of the President placed the whole island of Luzon under Enhance Community Quarantine (ECQ)

and subsequently the Province of Sorsogon had been placed to General Community Quarantine (GCQ) and at present under the Modified General Community Quarantine (MGCQ);

WHEREAS, during the period of ECQ, lockdown and stoppage or suspension of work in the public and private employment were enforced including transport operation of all kinds:

WHEREAS, due to such predicament, the city government issued a financial assistance to all qualified drivers and operators or franchise holders of tricycle-for-hire in its three (3) legislative districts, however, there are qualified recipients who failed to receive the said grant of assistance due to either the recipients were already dead, Overseas Filipino Workers (OFWs), Locally Stranded Individuals (LSIs), with health problems and/or old aged;

WHEREAS, this measure authorizes the immediate family members to receive the financial assistance issued by the city government amid COVID19 for and in behalf of the qualified drivers and operators or franchise holders of tricycle-for-hire who are already dead, Overseas Filipino Workers (OFWs), Locally Stranded Individuals (LSIs), with health problems and old aged, with the following additional documentary requirements, attached to their respective Certificate of Franchise to wit:

A. BENEFICIARIES OF DECEASED FRANCHISE HOLDER

- Death Certificate of the franchise holder
- Marriage Contract in case the surviving spouse is the claimant
- Birth Certificate in case the child is the claimant preferably of legal age and a written authorization to receive issued by the Mother, if still alive.

B. OVERSEAS FILIPINO WORKERS (OFWs)

Any document/s showing that the beneficiary is an Overseas Filipino Worker such
as but not limited to duplicate/photocopy of Overseas Employment Contract,
OFW ID, Working Visa, Passport or any certification/document to that effect.

Preferably, the claimant should be the spouse left in the Philippines, if still alive. In such case, a Marriage Contract should be submitted.

In the absence of the spouse, anyone of their children could substitute. In such case, a Birth Certificate should be submitted with the written authorization of his/her father/mother as the case maybe and if applicable.

C. LOCALLY STRANDED INDIVIDUALS (LSIs)

• Certification from the barangay that the beneficiary was stranded or locked down in any part of the Philippines.

Preferably, the claimant should be the spouse left in the barangay, if still alive. In such case, a Marriage Contract should be submitted.

In the absence of the spouse, anyone of their children could substitute. In such case, a Birth Certificate should be submitted with the written authorization of his/her father/mother, as the case maybe and if applicable.

D. WITH HEALTH PROBLEMS AND OLD AGED

- Medical Certificate (or)
- Certification from the barangay that the beneficiary is an old aged and physically not fit to travel.

Preferably, the claimant should be the spouse, if still alive. In such case, a Marriage Contract should be submitted.

In the absence of the spouse, anyone of their children could substitute. In such case, a Birth Certificate should be submitted with the written authorization of the beneficiary.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to authorize the immediate family members as herein identified to receive the financial assistance issued by the city government amid COVID19 for and in behalf of the qualified drivers and operators or franchise holders of tricycle-for-hire who are already dead, Overseas Filipino Workers (OFWs), Locally Stranded Individuals (LSIs), with health problems and old aged.
