**RESOLUTION ADOPTING THE CITY DEVELOPMENT COUNCIL
RESOLUTION NO. 05 - 2019 ENTITLED: RESOLUTION APPROVING THE FY
2020 ANNUAL INVESTMENT PLAN AND THE PROPOSED UTILIZATION OF
THE 20% DEVELOPMENT FUND FOR FISCAL YEAR 2020 FOR THE CITY OF
SORSOGON**

WHEREAS, Section 287 of the Local Government Code of 1991 mandates the local governments to appropriate no less than 20% of its annual Internal Revenue Allotment (IRA) share for development projects and prepare their respective Annual Investment Plan that would address the need of the people on economic, environmental and general services;

WHEREAS, the City Development Council is mandated to: formulate long-term, medium-term and annual socioeconomic development plans and policies; formulate the

medium-term and annual public investment programs; appraise and prioritize socioeconomic development programs and projects; and formulate local investment incentives to promote the inflow and direction of private investment capital as provided by Section 109 of the Local Government Code of the Philippines;

WHEREAS, the development projects identified are consistent with priorities under the local development plan and complements the overall national and global goals and aspirations;

WHEREAS, the programs, projects and activities to be funded by the 20% Development Fund for 2020 and those indicated in the Annual Investment Plan (AIP) will contribute to the improvement and attainment of socio-economic development outcomes;

WHEREAS, it is mandated that Local Government Units shall prepare their respective Annual Investment Plan that would address the need of the people on economic, social, environmental and general services;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to adopt the City Development Council Resolution No. 05-2019 entitled: Resolution approving the FY 2020 Annual Investment Plan and the proposed utilization of the 20% Development Fund for Fiscal Year 2020 for the city of Sorsogon;
