RESOLUTION URGING THE SORECO II MANAGEMENT TO FURNISH THE 7TH CITY COUNCIL RELEVANT DOCUMENTS IN RELATION TO THE COMMITTEE HEARING CONDUCTED BY THE COMMITTEE ON ENERGY OF THE SANGGUNIANG PANLALAWIGAN LAST JUNE 17, 2020.

WHEREAS, on June 10, 2020, the Hon. John Ryan C. Dioneda and Hon. Juan G. Guysayko, Sangguniang Panlalawigan Chairman of the Committee on Transportation, Energy and Utilities and Chairman of the Committee on Good Government, Public Accountability and Ethics invited among others the Chairman of the Committee on Energy chaired by the Hon. Franco Eric O. Ravanilla to tackle the hereunder issues scheduled on June 17, 2020 at 9:00 in the morning at the Sangguniang Panlalawigan Session Hall to wit;

1. Manifestations of Hon. Ryan C. Dioneda in relation to SORECO II Restructuring Agreement of PSALM dated August 08, 2019 and Status of Compliance of SORECO II;
2. COA Findings on Utilization of Sitio Electrification Program (SEP) released by National Electrification Administration (NEA) and other transaction of subsidies of SORECO II.
