RESOLUTION ADOPTING THE CITY DEVELOPMENT COUNCIL RESOLUTION NO. 06, SERIES OF 2019 ENTITLED: RESOLUTION FAVORABLY ENDORSING THE VARIOUS INFRASTRUCTURE PROJECTS OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-SORSOGON FIRST ENGINEERING OFFICE FOR FY 2020 TO THE REGIONAL DEVELOPMENT COUNCIL

WHEREAS, On September 17, 2019 a letter from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Sangguniang Panlungsod Members requesting for the adoption of the approved City Development Council Resolution No. 06, Series of 2019 entitled: Resolution favorably endorsing the various infrastructure projects of the Department Of Public Works and Highways - Sorsogon First Engineering Office for FY 2020 to the Regional Development Council;

WHEREAS, on September 26, 2019 a committee hearing was conducted for the purpose and therein revealed that the request would be beneficial to the interest of the city and its constituents thus favorably endorsing the adoption thereof;

WHEREAS, the lists of projects to be implemented are as follows, to wit;

1. Construction/Maintenance of Flood Mitigation Structure and Drainage System Construction/Rehabilitation of Gabao River Control, Sorsogon City;
2. Construction/Maintenance of Flood Mitigation Structures along Salvador H. Escudero III Diversion Road, Gomihan River, Downstream, Sorsogon City;
3. Construction/Maintenance of Flood Mitigation Structures along Salvador H. Escudero III Diversion Road, Sorsogon River, Downstream, Sorsogon City;
4. Construction/Maintenance of Flood Mitigation Structures and Drainage Systems Construction Gimaloto River Control, Sorsogon City;
5. Construction of Buhatan–San Vicente–San Ramon–San Isidro Rd, Sorsogon City;
6. Construction of San Isidro – Bangcal – San Roque Road, Sorsogon City;
7. Construction of Box Culvert at Maricrum - Cabarbuhan Road, Sorsogon City; and
8. Construction of Sorsogon City Coastal Road and Embankment, Sorsogon City.

WHEREAS, it is the mandate for the local government unit to exercise the powers expressly granted, those necessarily implied there from, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;
