**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO FACILITATE THE TRANSFER OF THE AMOUNTS DEPOSITED AT POSTAL BANK ACCOUNT NUMBERS 0021-002785-231 AND 0021-004709-271 TO THE DEVELOPMENT BANK OF THE PHILIPPINES ACCOUNT NUMBERS 0645-011564-082 AND 0645-011565-160 RESPECTIVELY AND THE CLOSURE OF THE ACCOUNTS WITH THE POSTAL BANK**

**WHEREAS,** among the items deliberated during the October 1, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru Mr. Noel G. Dreu, Secretary to the SP dated September 24, 2019, requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to facilitate the transfer of the amounts deposited at Postal Bank Account Numbers 0021-002785-231 and 0021-004709-271 to the Development

Bank of the Philippines Account Numbers 0645-011564-082 and 0645-011565-160 respectively and the closure of the accounts with the Postal Bank;

**WHEREAS**, at present the City Government of Sorsogon has an existing and active deposit at Postal Bank with account nos. 0021-002785-231 (₱ 464,653.22) and 0021-004709-271 (₱38,768,239.25);

**WHEREAS**, after the transfer has been facilitated, both Postal Bank accounts will be closed in line with the acquisition of Philippine Postal Savings Bank by the Land Bank of the Philippines;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to facilitate the transfer of the amounts deposited at Postal Bank Account Numbers 0021-002785-231 and 0021-004709-271 to the Development Bank of the Philippines Account Numbers 0645-011564-082 and 0645-011565-160 respectively and the closure of the accounts with the Postal Bank;
