**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO AGREEMENT RELATIVE TO THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) FUNDED PROGRAM FOR THE PROCUREMENT OF INSTRUCTIONAL MATERIALS, CONSTRUCTION SUPPLIES AND DEVICES FOR THE MAINTENANCE AND REPAIR OF DAY CARE CENTERS IN THE CITY OF SORSOGON**

**WHEREAS**, among the items deliberated during the October 1, 2019 Regular Session of the 7<sup>th</sup> City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City address to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP dated September 27, 2019 requesting for the passage of a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into agreement relative to the Early Childhood Care and Development (ECCD) funded program for the procurement of instructional materials, construction supplies and devices for the maintenance and repair of Day Care Centers in the City of Sorsogon;

**WHEREAS**, the City Government of Sorsogon will be facilitating the procurement of instructional materials, construction supplies and devices for the maintenance and repair of Day Care Centers within the territorial jurisdiction of the City of Sorsogon in which the fund thereof shall come from the Early Childhood Care and Development (ECCD);
