RESOLUTION MOST RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO PURCHASE THE LOT WITHIN THE PERIPHERY OF THE SORSOGON CITY PUBLIC MARKET OWNED BY HUAN KING LAO AS REPRESENTED BY HIS HEIRS AND SUCCESSORS IN INTEREST.

WHEREAS, thru a letter Ms. Anita Jao Rosas, Atty-in- Fact of Huan King Lao requested the Sanggunian Panlungsod to pass a resolution whereby the City Government shall waive and renounced its right and claim over a-portion of a parcel of land denominated as Lot No. 3323-B located at Barangay Sirangan, East District, Sorsogon City;

WHEREAS, the letter request was referred to the committee on City Government properties and the committee hearing for the purpose was conducted on March 15, 2020 in order to ascertain and determine the propriety of the request;

WHEREAS, in the course of the hearing, Engr. Base of the DENR admitted that the records of the clerk of court Bulwagan ng Katarungan was already rectified wherein it was reflected therein that the City Government has a claim over a portion of Lot No. 3323-B and where the Office of the City Assessor based the claim of LGU;

WHEREAS, Atty. Ringo Dichoso, Legal Counsel of the heirs of Huan King Lao requested for a right of way to the City Government being the declared owner of the adjacent lot which is the most feasible and nearest access to the road;

WHEREAS, in view of the obtaining circumstances and other attendant factors, the Hon. Franco Eric O. Ravanilla is inclined to believe that it would be to the best interest of the City Government of Sorsogon to purchase the aforesated lot for future use of the constituents;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to most respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to purchase the lot within the periphery of the Sorsogon City Public Market owned by Huan King Lao as represented by his heirs and successors in interest;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Joven G. Laura**, resolve as it is hereby resolved to most respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to purchase the lot within the periphery of the Sorsogon City Public Market owned by Huan King Lao as represented by his heirs and successors in interest;
