RESOLUTION FAVORABLY ENDORSING THE PROPOSED CONSTRUCTION OF MULTI-PURPOSE BUILDING CUM EVACUATION CENTER AT BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY IN THE AMOUNT OF ONE HUNDRED MILLION (P100,000,000.00) PESOS AND PART OF THE APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM AND 2019 ANNUAL INVESTMENT PLAN

WHEREAS, among the items deliberated during the October 08, 2019 Regular Session is the letter request from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C.
