**RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE CITY MAYOR MA. ESTER E. HAMOR TO DONATE THE PARCEL OF LAND UNDER ARP NO. 2011-03-0002-00298, WITH AN AREA OF 660 SQUARE METERS, LOCATED AT BARANGAY BASUD, WEST DISTRICT, SORSOGON CITY IN FAVOR OF THE SAID BARANGAY AND THEREBY GRANTING A STANDING AUTHORITY TO ENTER INTO A DEED OF DONATION IN RELATION THERETO**

**WHEREAS**, the Barangay Hall of Brgy. Basud, including its Day Care Center and Public Market stand on the lot of the city government and the Barangay Council is requesting that the same be donated to them for its maintenance and improvement projects;

**WHEREAS**, the City Assessor's Office, under its Tax Declaration No. ARP No. 2011-03-0002-00298 positively identified the land in issue with the municipal/city government of Sorsogon as the owner thereof and measured with 660 square meters;

**WHEREAS**, the barangay is in possession of the said lot since time immemorial, thus, donation of the same in favor of the said barangay is just, proper and appropriate;


**WHEREAS**, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, **enhance economic prosperity and social justice**, maintain peace and order and **preserve the comfort and convenience of their inhabitants**;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to respectfully request the Honorable City Mayor Ma. Ester E. Hamor to donate the parcel of land under ARP No. 2011-03-0002-00298, with an area of 660 square meters, located at Barangay Basud, West District, Sorsogon City in favor of the said barangay and thereby granting a standing authority to enter into a Deed of Donation in relation thereto;

**RESOLVED FURTHER**, that copies of this resolution be furnished to all concerned for their information, guidance and appropriate action.
