**RESOLUTION ENACTING AN ORDINANCE CREATING THE SORSOGON CITY COOPERATIVES DEVELOPMENT OFFICE AND THE POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I (CITY COOPERATIVES OFFICER) AND APPROPRIATING FUNDS THEREOF.**

**WHEREAS**, Local Government Units (LGUs) plays a major role in community development, provide links between people and government, addresses community problems and concerns, enforce policies and hold influence over its jurisdictions;

**WHEREAS**, there is a need to identify and create offices and positions that would most efficiently deliver basic services to the public in consonance with the present needs of our society;

**WHEREAS**, under RA 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod, subject to the provisions of the same and pertinent laws, has also the power/authority to determine the powers and duties of officials and employees of the city. (RA 7160, Sec. 458(1) (vii);

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to enact an ordinance creating the Sorsogon City Cooperatives Development Office and the Position of City Government Department Head I (City Cooperatives Officer) and Appropriating Funds Thereof;

**NOW THEREFORE**, on motion of **Hon. Ralph Walter R. Lubiano**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby done to enact an ordinance creating the Sorsogon City Cooperatives Development Office and the Position of City Government Department Head I (City Cooperatives Officer) and Appropriating Funds Thereof;

## *City Ordinance No. 14, Series of 2020*

**AN ORDINANCE CREATING THE SORSOGON CITY COOPERATIVES DEVELOPMENT OFFICE AND THE POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I (CITY COOPERATIVES OFFICER) AND APPROPRIATING FUNDS THEREOF.**

Be it ordained by the 7<sup>th</sup> Sangguniang Panlungsod in session duly assembled that:

**SECTION 1: TITLE**

*This ordinance shall be known as the “City Cooperatives Ordinance of 2020”.*

**SECTION 2: SCOPE/COVERAGE**

*This ordinance shall cover the creation of the City Cooperatives Development Office and the position of City Government Department Head I (City Cooperatives Officer) and appropriating funds therefore.*

**SECTION 3: CREATION OF THE CITY COOPERATIVES DEVELOPMENT OFFICE AND THE POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I (CITY COOPERATIVES OFFICER)**

*It is hereby created the CITY COOPERATIVES DEVELOPMENT OFFICE AND THE POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I (CITY COOPERATIVES OFFICER) with the following qualification standards, to wit:*

**SECTION 4: APPROPRIATIONS**

The City Government shall appropriate the corresponding funds annually and provide necessary funding requisites for the salary and other monetary benefits and incentives for the aforementioned office and plantilla position as herein created that are allowed under the existing laws and administrative issuances relative thereto.

**SECTION 5: REPEALING CLAUSE**

All ordinances, resolutions, rules and regulations, or any part(s) thereof which are inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

**SECTION 6: SEPARABILITY CLAUSE**

If any person or reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 7: EFFECTIVITY**

This ordinance shall take effect immediately upon its approval by the Sangguniang Panlungsod.


