**RESOLUTION ADOPTING THE CITY DEVELOPMENT COUNCIL RESOLUTION NO. 07, SERIES OF 2019 ENTITLED: RESOLUTION AMENDING THE MEMBERSHIP OF THE CITY DEVELOPMENT COUNCIL AND CDC EXECUTIVE COMMITTEE AND THE RECONSTITUTION OF THE CDC SECTORAL COMMITTEES AND THE LOCAL PROJECT MONITORING COMMITTEE OF THE CITY OF SORSOGON**

**WHEREAS**, On September 17, 2019 a letter from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Sangguniang Panlungsod Members requesting for the adoption of the approved City Development Council Resolution No. 07, Series of 2019 entitled: Resolution amending the membership of the City Development Council and CDC executive committee and the reconstitution of the CDC Sectoral Committees and the Local Project Monitoring Committee of the City of Sorsogon;
