RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT REPRESENTED HEREIN BY DOLE REGIONAL OFFICE V ASSISTANT REGIONAL DIRECTOR ROVELINDA A. DE LA ROSA RELATIVE TO THE GOVERNMENT INTERNSHIP PROGRAM (GIP)

WHEREAS, on October 7, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requested for the passage of a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Understanding (MOU) with the Department of Labor and Employment represented herein by DOLE - Regional Office V Assistant Regional Director Rovelinda A. De La Rosa relative to the Government Internship Program (GIP);

WHEREAS, this program aims to engage its beneficiaries into public service, provide young workers with opportunity to demonstrate their skills in the field of public service and fast track the implementation and monitoring of DOLE programs;

WHEREAS, GIP Beneficiaries shall be tasked to assist DOLE and other Government Agencies personnel in the performance of their functions which are considered not highly-technical in nature;

WHEREAS, in the current year, fifteen (15) GIP Beneficiaries shall be assigned to the city government wherein they will be remunerated with a daily rate of PHP 310.00/day from October to December, 2019 funded and will be released by the DOLE;

WHEREAS, attached thereto is the draft Memorandum of Understanding (MOU) for perusal of the August Body;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Understanding (MOU) with the Department of Labor and Employment represented herein by DOLE - Regional Office V Assistant Regional Director Rovelinda A. De La Rosa relative to the Government Internship Program (GIP);

NOW THEREFORE, on motion of **Hon. Mary Ellen D. Jamisola**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolve as it is hereby resolved to authorize Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Understanding (MOU) with the Department of Labor and Employment represented herein by DOLE - Regional Office V Assistant Regional Director Rovelinda A. De La Rosa relative to the Government Internship Program (GIP);
