RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH (DOH) REPRESENTED HEREIN BY ITS DOH-ROV OIC-DIRECTOR IV ERNIE V. VERA RELATIVE TO THE IMPLEMENTATION OF THE FOURMULA ONE PLUS BOTIKA NG BAYAN (F1+BNB)

WHEREAS, on October 4, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requested for the passage of a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with the Department of Health (DOH) represented herein by its DOH-ROV OIC-Director IV Ernie V. Vera relative to the implementation of the FOURmula One Plus Botika ng Bayan (F1+BNB);

WHEREAS, FOURmula One Plus Botika ng Bayan (F1+BNB) program shall be implemented in City's Rural Health Units (RHU) in order to lessen additional transportation expenses for clients and patients and address other health-related issues such as cost-effectiveness of treatment, antimicrobial resistance and adverse drug events;

WHEREAS, consistent with the revitalized and remodeled "Botika ng Bayan" which shall be adopted with the use of government instruments such as but not limited to pooled procurement, parallel drug importation and price-volume direct negotiation with pharmaceutical manufacturers for single-source essential medicines;

WHEREAS, attached to the letter request is the draft Memorandum of Agreement (MOA) for perusal of the August Body;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with the Department of Health (DOH) represented herein by its DOH-ROV OIC-Director IV Ernie V. Vera relative to the implementation of the FOURmula One Plus Botika ng Bayan (F1+BNB);
