RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DR. FERNANDO B. DURAN SR. MEMORIAL HOSPITAL (DFBDSMH) NEW-BORN HEARING CENTER REPRESENTED BY PROVINCIAL GOVERNOR FRANCIS JOSEPH G. ESCUDERO AS THE REFERRAL FACILITY RELATIVE TO THE HEARING SCREENING OF NEW BORNS FROM BACON DISTRICT HEALTH OFFICE BIRTHING FACILITY

WHEREAS, on October 4, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requested for the passage of a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with Dr. Fernando B. Duran Sr. Memorial Hospital (DFBDSMH) New-Born Hearing Center represented by the Provincial Governor Francis Joseph G. Escudero as the referral facility relative to the hearing screening of new born from Bacon District Office Birthing Facility;

WHEREAS, the marginalized sector shall benefit from this program specially those children suffering from hearing impairment and likewise ease the burden of the parents in terms of expenses in seeking medical attention from other medical institutions;

WHEREAS, attached to the letter request is the draft Memorandum of Agreement (MOA) for perusal of the August Body;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with Dr. Fernando B. Duran Sr. Memorial Hospital (DFBDSMH) New-Born Hearing Center represented by the Provincial Governor Francis Joseph G. Escudero as the referral facility relative to the hearing screening of new born from Bacon District Office Birthing Facility;

NOW THEREFORE, on motion of Hon. Mary Ellen D. Jamisola, duly seconded by Hon. Rebecca D. Aquino, resolve as it is hereby resolved to authorize Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with Dr. Fernando B. Duran Sr. Memorial Hospital (DFBDSMH) New-Born Hearing Center represented by the Provincial Governor Francis Joseph G. Escudero as the referral facility relative to the hearing screening of new born from Bacon District Office Birthing Facility;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and entered into by and between:

DR. FERNANDO B. DURAN SR. MEMORIAL HOSPITAL NEWBORN HEARING CENTER, represented by GOVERNOR FRANCIS JOSEPH G. ESCUDERO, a duly registered establishment with address at Macabog, Sorsogon City hereinafter referred to as the FIRST PARTY;

-AND-

BACON DISTRICT HEALTH OFFICE BIRTHING FACILITY, is a duly existing health facility with address at Poblacion, Bacon District Sorsogon City and represented herein by MAYOR MA. ESTER E. HAMOR, hereinafter referred to as the SECOND PARTY;

WITNESSETH, that:

WHEREAS, FIRST PARTY is operating a Level 2 Public Hospital named **DR. FERNANDO B. DURAN SR. MEMORIAL HOSPITAL**, HEREIN named as DFBDSMH, that provides hearing screening for newborns/infants, while the SECOND PARTY is a public institution that owns and operates birthing center which provide maternity health care/services to the public;

WHEREAS, FIRST PARTY hereby offers to SECOND PARTY one of its services for the evaluation of hearing loss particularly the newborn hearing screening services to the SECOND PARTY; On the other hand, SECOND PARTY willingly accepts such service being offered by the FIRST PARTY;

NOW, THEREFORE, FOR AND IN CONSIDERATION of the above premises, both FIRST PARTY AND SECOND PARTY hereby agree and bind themselves to do and perform the following under the terms and conditions stated hereunder:

TERMS AND CONDITIONS:

Responsibilities of FIRST PARTY:DR. FERNANDO B. DURAN SR MEMORIAL HOSPITAL NEWBORN HEARING CENTER

- 1. To provide newborn hearing screening service to patients of Second Party for a fee agreed upon by parties;
- 2. To acceptpatient referred by the Second Party on an agreed schedule and conduct such screening thereat upon notice given by Second Party;
- 3. To notify second party when first party could not perform its services rendered at least a day prior to agreed schedule date.
- 4. To inform and explain the procedure to the parent(s)/guardian(s)and its subsequent test result:
- 5. To secure consent for the conduct of the screening, including the consent of the release of result to the SECOND PARTY.
- 6. To provide parent(s)/guardian(s) an official result of the screening;
- 7. To provide the Second Party a copy of the screening result and recommendation;
- 8. If a patient's result is "refer" (meaning, there is a finding that needs further/second assessment), then First Party shall rescreen the patient for free within thirty calendar days from the first screening;
- 9. To charge second party the amount of P150.00 per patient as newborn hearing screening fee and to provide the SECOND PARTY a Billing Statement for the screening conducted.
- 10. To issue an official receipt in favor of second party upon payment;

Responsibilities of Second PartyBACON DISTRICT HEALTH OFFICE BIRTHING FACILITY:

- 1. To inform patient about the availability of newborn hearing screening services rendered by the first party.
- 2. To inform Philhealth patient that newborn hearing screening is already included in their Philhealth benefits and that for newborn hearing screening to be credited by Philhealth, patient's initial hearing screening should be done within a month after delivery.
- 3. To schedule patient for initial newborn hearing screening with the First Party as per agreed schedule. For Philhealth patients, it must not be beyond 30 days after delivery.
- 4. For patients who obtained a "refer" result during the initial screening, the SECOND PARTY shall coordinate with the FIRST PARTY for the schedule of the re-screening within thirty (30) calendar days.
- 5. To notify First party on expected number of patient/s for newborn hearing screening on the next scheduled date and of any unexpected change/s such as transfer of schedule, etc. via call or text message at least a day prior to the scheduled date.
- 6. To pay First Party the amount of P150.00 per patient as newborn hearing screening fee.
- 7. To include the newborn hearing screening fee in the billing/Philhealth claims of patient;
- 8. To refer the patient for confirmatory test and possible referral to ENT specialist.
