**RESOLUTION MOST RESPECTFULLY REQUESTING THE CITY INTER-AGENCY TASK FORCE (IATF) FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES THROUGH PLTCOL. BENITO E. DIPAD, JR., CITY CHIEF OF POLICE FOR THE REACTIVATION OR REESTABLISHMENT OF BOUNDARY CHECK POINTS AS MONITORING SYSTEM IN THE CITY OF SORSOGON**

**WHEREAS**, on March 17, 2020, a memorandum order from the Office of the President placed the whole island of Luzon under Enhance Community Quarantine (ECQ) due to COVID 19 pandemic and subsequently the Province of Sorsogon had been placed to General Community Quarantine (GCQ) and then to Modified General Community Quarantine (MGCQ);

**WHEREAS**, placing the province of Sorsogon to General Community Quarantine (GCQ) and subsequently to Modified General Community Quarantine (MGCQ), some security protocols such as boundary and barangay check points were relaxed and loosen; **WHEREAS**, considering the recent development or the increasing numbers of Covid 19 positives in the Province of Sorsogon, there is a need to reactivate or reestablish boundary check points in all city boundaries as an effective monitoring system;

**WHEREAS**, the reactivation or reestablishment of boundary check points in all city boundaries could somehow relieve worries of every human mind in the city jurisdiction from the sudden and drastic increase of Covid cases in the communities;

**WHEREAS**, establishment of boundary check points in all city boundaries is a proven monitoring system to combat community transmission of the virus;

**WHEREAS**, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

**NOW THEREFORE**, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by City Councilor Joven G. Laura, resolved as it is hereby resolve to most respectfully request the City Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases through PltCol. Benito E. Dipad, Jr., City Chief of Police for the reactivation or reestablishment of boundary check points as monitoring system in the City of Sorsogon.
