RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT THE DONATION OF A PARCEL OF LAND CONTAINING AN AREA OF ONE HUNDRED SIXTY (160) SQUARE METERS REGISTERED IN THE NAME OF MRS. MILAGROS S. VERA LOCATED AT BARANGAY SAN JUAN, BACON DISTRICT, SORSOGON CITY.

WHEREAS, among the items deliberated during the July 14, 2020 Regular Session of the 7th City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Dan G. Alcala, Acting Secretary to the Sangguniang Panlungsod dated July 13, 2020 respectfully requesting for the passage of a resolution authorizing the Local Chief Executive to accept the donation of a parcel of land

containing an area of One Hundred Sixty (160) square meters registered in the name of Mrs. Milagros S. Vera located at Barangay San Juan, Bacon District, Sorsogon City;

WHEREAS, the donation is in connection with the construction of Bacon Water System which site is within the property owned by Mrs. Milagros S. Vera and said project is initiated by the Department of Public Works and Highways (DPWH) assisted by the City Government of Sorsogon with the end view of providing steady supply of clean water in Bacon District;

WHEREAS, among the documents attached thereof is the Draft Deed of Donation for consideration and perusal of the 7th City Council;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to accept the donation of a parcel of land containing an area of one hundred sixty (160) square meters registered in the name of Mrs. Milagros S. Vera located at Barangay San Juan, Bacon District, Sorsogon City;

NOW THEREFORE, on incidental motion of **City Councilor Erwin J. Duana**, duly seconded by **City Councilor Rebecca D. Aquino**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Vera located at Barangay San Juan, Bacon District, Sorsogon City;
