## Resolution No. 171, Series of 2020

RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FILED BY MR. ALBERT ESCULLAR AGAINST PUNONG BARANGAY JEFFREY LOUIE ESTIDOLA OF BARANGAY ABUYOG, EAST DISTRICT, SORSOGON CITY BEFORE THE SANGGUNIANG PANLUNGSOD BY VIRTUE OF THE AFFIDAVIT OF DESISTANCE EXECUTED BY THE COMPLAINANT.

**WHEREAS**, pursuant to Section 61 (c) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that;

SECTION 61. Form and Filing of Administrative Complaints. – A verified complaint against any erring local elective official shall be prepared as follows:

- (a) A complaint against any elective official of a province, a highly urbanized city, an independent component city or component city shall be filed before the Office of the President;
- (b) A complaint against any elective official of a municipality shall be filed before the sangguniang panlalawigan whose decision may be appealed to the Office of the President; and
- (c) A complaint against any elective barangay official shall be filed before the sangguniang panlungsod or sangguniang bayan concerned whose decision shall be final and executory.

WHEREAS, among the items deliberated upon by the 7<sup>th</sup> City Council during the July 07, 2020 regular Session was the Verified Complaint filed by Mr. Albert Escullar against Punong Barangay Jeffrey Louie Estidola of Barangay Abuyog, East District, Sorsogon City before the Sangguniang Panlungsod for Abuse of Authority;

**WHEREAS,** the matter was officially referred to the Committee on affairs for possible amicable settlement with the presence of the parties herein mentioned;

**WHEREAS,** on July 10, 2020, a Committee Hearing was called for the purpose and parties were present to discuss the matter;

**WHEREAS,** on July 13, 2020, Mr. Albert Escullar, Complainant of the herein mentioned administrative complaint appeared before the Office of the Secretary to the Sangguniang Panlungsod and submitted his Affidavit of Desistance for the herein mentioned Administrative Case;

**WHEREAS,** foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution dismissing the Administrative Complaint filed by Mr. Albert Escullar against Punong Barangay Jeffrey Louie Estidola of Barangay Abuyog, East District, Sorsogon City before the Sangguniang Panlungsod by virtue of the Affidavit of Desistance executed by the Complainant;

**NOW THEREFORE,** on motion of **City Councilor Joven G. Laura**, duly seconded by **City Councilor Franco Eric O. Ravanilla**, resolve as it is hereby resolved to dismiss the Administrative Complaint filed by Mr. Albert Escullar against Punong Barangay Jeffrey Louie Estidola of Barangay Abuyog, East District, Sorsogon City before the Sangguniang Panlungsod by virtue of the Affidavit of Desistance executed by the Complainant;
