RESOLUTION FAVORABLY ENDORSING SORECO II'S APPLICATION FOR CONFIRMATION AND APPROVAL OF FORCE MAJURE EVENT CAPITAL EXPENDITURE PROJECT NAMELY, REPAIR, RESTORATION AND/OR REHABILITATION OF DISTRIBUTION SYSTEM, BUILDING FACILITIES AND EQUIPMENT DAMAGED BY TYPHOON TISOY, WITH APPLICATION FOR AUTHORITY TO SECURE LOAN FROM THE NATIONAL ELECTRIFICATION ADMINISTRATION (NEA).

WHEREAS, in compliance with Energy Regulation Commission's (ERC's) Rules of Practice and Procedure, SORECO II, through Engr. Josef Erwin R. Tabuena, General Manager, furnished the Office of the Sangguniang Panlungsod copies of their Application for Confirmation and Approval of Force Majure Event Capital Expenditure Project namely, Repair, Restoration and/or Rehabilitation of Distribution System, Building Facilities and

Equipment damaged by Typhoon Tisoy, with Application for Authority to Secure Loan from the National Electrification Administration (NEA);

WHEREAS, the matter was officially referred to the Committee on Energy and on July 01, 2020 a committee hearing was called for this purpose inviting the presence of SORECO II management and Members of the committee on Energy;

**WHEREAS**, upon discussion of the surrounding issues in relation to the request, the Committee on Energy was convinced of the necessity of the matter being sought by SORECO II Management;

**WHEREAS**, on July 14, 2020 Regular Session of the 7th city council, a committee report regarding the matter was rendered by the Committee on Energy with the recommendation to favorably endorse the herein mentioned application to the National Electrification administration, thus this resolution;
