RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A RICE SALES MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) REPRESENTED BY ITS PROVINCIAL MANAGER NOEMI A. MORFE

WHEREAS, on October 4, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requested for the passage of a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Rice Sales Memorandum of Agreement (MOA) with the National Food Authority (NFA) represented by its Provincial Manager Noemi A. Morfe;

WHEREAS, the National food Authority (NFA) has been a long time partner of the City Government in providing people with immediate assistance during times of calamities and other disaster preparedness activities;

WHEREAS, the said agency has allowed to purchase rice on cash or credit for stockpiling, prepositioning, relief distribution operations as well as for other programs and activities of the city government;

WHEREAS, this was strengthened through an agreement executed by and between the City Government and the National Food Authority;

WHEREAS, the City Government intends to renew the agreement thereof in order to sustain the disaster preparedness programs and maintain the eminence of the response during emergency situations;

WHEREAS, attached to the letter-request is the draft Rice Sales Memorandum of Agreement (MOA) for perusal of the August Body;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Rice Sales Memorandum of Agreement (MOA) with the National Food Authority (NFA) represented by its Provincial Manager Noemi A. Morfe;

NOW THEREFORE, on motion of Hon. Fernando David H. Duran, III, duly seconded by Hon. Franco Eric O. Ravanilla, resolve as it is hereby resolved to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Rice Sales Memorandum of Agreement (MOA) with the National Food Authority represented by its Provincial Manager Noemi A. Morfe;

RESOLVED FURTHER, that the Rice Sales Memorandum of Agreement (MOA) entered into by the parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Office of the Secretary to the Sangguniang Panlungsod for records and archive purposes;
