RESOLUTION AUTHORIZING HON. MARK ERIC C. DIONEDA, CITY VICE MAYOR, SORSOGON CITY TO CREATE A TECHNICAL WORKING GROUP THAT WILL SERVE AS THE SECRETARIAT FOR ADMINISTRATIVE CASES WITH THE AUTHORITY TO DRAFT ISSUANCES AND DECISIONS OF ALL PENDING AND SUBSEQUENT ADMINISTRATIVE CASES UNDER THE DIRECT CONTROL AND SUPERVISION OF THE SANGGUNIANG PANLUNGSOD IN EXERCISE OF ITS QUASI-JUDICIAL FUNCTIONS

**WHEREAS,** the previous City Council has number of administrative cases left undecided and the 7<sup>th</sup> City Council has to act on it;

WHEREAS, considering that some of the members of the 7<sup>th</sup> City Council are neophytes or having no idea of the nature, chronological order of events, evidences presented during the series of hearing conducted by the previous city council for the aforesaid pending cases, they shall be appraised and accorded with proper orientation and information;

WHEREAS, the City Vice Mayor, being the head of the Sangguniang Panlungsod in its exercise of its legislative and quasi-judicial functions shall be provided with such authority to create a Technical Working Group to facilitate the conduct of summarization of all pending administrative cases for the benefits of all members of the 7<sup>th</sup> City Council;

WHEREAS, the Technical Working Group shall serve as the Secretariat for all pending and subsequent administrative cases filed before the Sangguniang Panlungsod with the authority to draft decisions and issuances upon lawful order, instruction and directive of the Sangguniang Panlungsod;

WHEREAS, the technical working group shall be composed of personnel from the Office of the City Vice Mayor and from the Office of the Secretary to the Sangguniang Panlungsod;

WHEREAS, this measure provides authority to the City Vice Mayor to issue the corresponding Office Memorandum to the concerned personnel to compose the Technical Working Group or the Secretariat for Administrative Cases;

NOW THEREFORE, on motion of Hon. Ma. Teresa D. Perdigon, duly seconded by Hon. Mary Ellen D. Jamisola, resolved as it is hereby resolve to authorize Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City to create a Technical Working Group that will serve as the secretariat for administrative cases with the authority to draft issuances and decisions of all pending and subsequent administrative cases under the direct control and supervision of the Sangguniang Panlungsod in exercise of its quasi-judicial functions;

**RESOLVED further,** that copies of this resolution be furnished to all concerned for their information and guidance.
