RESOLUTION AUTHORIZING THE ISSUANCE OF TEMPORARY FRANCHISE PLATE NUMBER TO 324 NEW FRANCHISES ISSUED UNDER RESOLUTION NO. 156, SERIES OF 2019 WHICH APPROVED ALL APPLICATIONS FOR NEW FRANCHISE (CY 2016- APRIL 2019) PASSED AND APPROVED BY THE PREVIOUS CITY COUNCIL AND THEREBY CONFERRING THE AUTHORITY OF HON. CITY MAYOR MA. ESTER E. HAMOR, CITY VICE MAYOR MARK ERIC C. DIONEDA AND HON. NESTOR J. BALDON, CHAIRMAN OF THE COMMITTEE ON TRICYCLE FRANCHISE OF THE SANGGUNIANG PANLUNGSOD AS SIGNATORIES THERETO

WHEREAS, the Sangguniang+ Panlungsod through its Committee on Tricycle Franchise, had approved numbers of franchise, by batch, in consonance with Resolution No. 156, Series of 2019, passed and approved by the previous city council, which approved all applications for new franchise (CY 2016- April 2019);

WHEREAS, the last batch involving 442 applications for new franchise were processed and 116 of which were given tricycle franchise plate, the last available tricycle franchise plate in the SP Tricycle Franchising Section;

WHEREAS, due to unavailability of tricycle franchise plates for the remaining 326 new franchises, a temporary franchise plates in a plastic laminated material shall be issued and distributed in temporary replacement of the official tricycle franchise plates, which are still on the procurement process;

WHEREAS, the Sangguniang Panlungsod, by virtue of provisions under RA 7160, otherwise known as the Local Government Code of 1991, subject to the guidelines prescribed by the Department of Transportation and Communications has the power to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city.(RA 7160, Sec.458 (3)(vi));

WHEREAS, Republic Act 9485 otherwise known as the Anti-Red Tape Law (ARTA) of 2007 mandates all government offices to simplify frontline service procedures, formulate service standards to observe in every transaction and make known these standards to their clients;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Jo Abegail C. Dioneda**, resolved as it is hereby resolve to authorize the issuance of temporary franchise plate number to 324 new franchises issued under Resolution No. 156, Series of 2019 which approved all applications for new franchise (CY 2016- April 2019) passed and approved by the previous city council and thereby conferring the authority of Hon. City Mayor Ma. Ester E. Hamor, City Vice Mayor Mark Eric C. Dioneda and Hon. Nestor J. Baldon, Chairman of the Committee on Tricycle Franchise of the Sangguniang Panlungsod as signatories thereto.
