**RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH (DOH) REPRESENTED BY ITS CHD – BICOL REGIONAL DIRECTOR ERNIE V. VERA RELATIVE TO THE IMPLEMENTATION OF REPAIR/RENOVATION/COMPLETION/UPGRADING AND/OR CONSTRUCTION OF THE BARANGAY HEALTH STATIONS AT SAN PASCUAL, BACON DISTRICT AND BARANGAY PEÑAFRANCIA, WEST DISTRICT, ALL IN THE CITY OF SORSOGON**

**WHEREAS**, on October 11, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requesting for the passage of a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with the Department of Health (DOH) represented by its CHD – Bicol Regional Director Ernie V. Vera relative to the implementation of repair/renovation/completion/upgrading and/or construction of the Barangay Health Stations at San Pascual, Bacon District and Barangay Peñafrancia, West District, all in the City of Sorsogon;

**WHEREAS**, the Department of Health (DOH) has provided the City of Sorsogon grants intended for the Health Facility Enhancement (HFEP) Projects amounting to Five Hundred Thousand (₱500,000.00) Pesos for the Barangay Health Station of Barangay San Pascual in Bacon District and One Million Pesos (₱1,000,000.00) Pesos for the Barangay Health Station of Barangay Peñafrancia in West District, all in the City of Sorsogon;

**WHEREAS**, this grant is for the purpose of improving the access of the constituents to quality medical services in line with the Philippine Development Plan 2017-2022 which includes the upgrading of government health facilities among others;

**WHEREAS**, attached to the letter request is the draft Memorandum of Agreement (MOA) for perusal of the August Body;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing Hon. Ma. Ester E. Hamor, City Mayor to enter into a Memorandum of Agreement (MOA) with the Department of Health (DOH) represented by its CHD – Bicol Regional Director Ernie V. Vera relative to the implementation of repair/renovation/completion/upgrading and/or construction of the Barangay Health Stations at San Pascual, Bacon District and Barangay Peñafrancia, West District, all in the City of Sorsogon;
