RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE SORSOGON STATE COLLEGE – CASTILLA CAMPUS REPRESENTED BY ITS PRESIDENT, DR. HELEN R. LARA, RELATIVE TO THE CONDUCT OF ITS FARM PRACTICUM PROGRAM

WHEREAS, on October 4, 2019, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City thru a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP requesting for the passage of a resolution authorizing Hon. Ma. Ester E.
